1. FOREIGN TAXATION WORKSHOP



IFIM College organized a workshop on 'Careers in Corporate Taxation' on September 2, 2025, at the college auditorium. The session was conducted by Mr. Anantha Lakshmanarao, Associate Director at KPMG, who has over 22 years of experience in taxation and consulting.

A total of 113 students from MBA, BBA, and BCom programs, along with faculty members, actively participated in the event. The workshop aimed to give students a clear understanding of the career opportunities in foreign taxation, particularly in US and UK contexts, and the skills required to succeed in this growing field.

Mr. Anantha highlighted career pathways in multinational organizations, especially within Big Four firms, where opportunities in tax compliance, consulting, and advisory are expanding. He explained the technical skills needed, such as knowledge of global tax laws, treaty understanding, and strong communication and analytical abilities. Drawing from his career journey, he shared real-world insights on challenges and opportunities in international taxation, which gave students a practical perspective on how to prepare for such roles.

The session was highly engaging and interactive. Students appreciated the provided on professional clarity certifications like the ADIT, which can strengthen career prospects in this domain. The workshop bridged academic knowledge with industry expectations and encouraged students to consider corporate taxation as a promising global career path

2. DIGITAL MARKETING WORKSHOP

The Placement Department organized a Digital Marketing Workshop on September 3, 2025, at the college auditorium for postgraduate (MBA) and undergraduate (B.Com and BBA) students. The session was conducted by industry experts and certified professionals from Li-Mat Solutions Pvt. Ltd., Electronics City Phase 1. The objective was to introduce students to the fundamentals of digital marketing while giving them hands-on experience with essential tools such as Search Engine Optimization (SEO) and Google Analytics. The workshop witnessed the participation of 140 students across MBA and undergraduate programs.



The resource provided persons students with a comprehensive understanding of digital marketing Sessions concepts. covered topics such important as an introduction to digital channels and opportunities, SEO career fundamentals, Google Analytics dashboards, and content strategy. Students also gained exposure to practical aspects including keyword

research, website optimization, content creation, blogging, and social media integration.

A live demonstration involving real-time SEO audits and campaign simulation helped students connect theoretical knowledge with practical applications. The workshop bridged the gap between academic learning and industry expectations.
